PAGEANT RULES

- 1. Entry Fee is \$40.00 and must be submitted with the Application.
- 2. Enclose an additional \$10.00 and photo with Application, if participating in the photogenic competition.
- 3. Must be a resident of Jasper County, attend school in Jasper County, have a parent who went to school in Jasper County or if your parent(s) owns property in Jasper County
- 4. Contestant's age must be appropriate with each division. Age as of Gopher Hill Festival Day October 5, 2023
- 5. Gopher Hill Festival Committee reserves the right to cancel or combine any age group due to a low number of participants.
- 6. Refunds will only be given to entries of any age group that is cancelled by the Gopher Hill Committee.
- 7. Pageant starts at 10:00 a.m. A rolling schedule will be used. If contestant is not present at the time of his/her division, contestant will be disqualified.
- 8. Judging will be by a panel of three accredited judges (accredited or working on accreditation by the Miss South Carolina USA Pageant.
- 9. Judging will be based on: Beauty, Smile, Personality, Modeling, Eye Contact, and Overall Appearance.
- 10. Girls should wear a pageant dress (long or short, your preference). Boys should wear dress clothes or suits.
- 11. Only **ONE** adult will be allowed backstage with the contestant.
- 12. There is an optional photogenic competition in each age division. While every precaution will be taken to ensure that all photographs are returned, the Gopher Hill Committee and any of its volunteers are not responsible for lost or damaged photographs. Please make sure all photos are turned in no later than Friday nights rehearsal
- 13. Parents of winners are encouraged to enter their child in area parades. However, transportation, floats and/or cars are the responsibility of the parents and will not be provided by the Festival Committee.
- 14. Judges decisions are final.
- 15. Should any question regarding any aspect of the pageant arise or should there be any discrepancy in the interpretation of pageant rules, the decision of the pageant chairperson shall be final.
- 16. The first runner up from each division will be crowned Master/Miss Gopher Hill; the second runner up will be Crowned Master/Miss Ridgeland
